President's Report 2022/23 Financial Year

I would like to present my report on behalf of the Board for year ending 2022 – 2023 and to acknowledge and thank fellow Board members and the staff at Bubup Wilam for their continued hard work and commitment to ensure that we provide the best services for our families and children.

The Executive staff provide detailed reports on the daily operation of Bubup. Staff have worked tirelessly throughout this time to ensure that this organisation continues to provide a nurturing and safe environment for our children.

During this financial year Bubup Wilam celebrated NAIDOC week, which families and children engaged in. Bubup Wilam had a cleansing ceremony and a morning tea, children participated in banner making, followed by a Bubup NAIDOC march around the oval behind TRAC with the children, families and staff.

A highlight that families and children really enjoyed during NAIDOC week, was attending the 'Bubup Ball'. The children dressed up for the ball, sat down together on one big table for lunch and had fun taking photos with their friends and families at the photo booth and there was a lot of dancing.

Bubup Wilam also celebrated our 10 year Anniversary Dinner at San Remo Ballroom in October 2022 with approximately 300 guests that attended on the night.

President's Report 2022/23 Financial Year

End of Year Celebration occurred on the 15 December 2022. We had 18 children graduate from the 4 year old room and 10 Bubup employees graduate; 1 employee completed Leadership Management Diploma, 3 employees completed their Early Childhood Education and Care Cert III and 6 employees completed their Early Childhood Education and Care Diploma.

Bubup Wilam continued the tradition by celebrating the end of the year at Funfields with families, staff, alumni families and friends; 365 people attended, which did not include the children under 100cm that enter free. In March 2023 a 'Special Persons Day' was held at Bubup Wilam to kick off the year, bringing families and community together and to connect.

I wish to thank our Board members for their commitment and vision to ensure the organisation is governed effectively, which in turn ensures Bubup Wilam can provide an excellent standard of care and best model of practise to the community and a great place to work for our staff.

Executive Officer's Report

CEO Report 2022/23 Financial Year

Welcome to our AGM for the 2022 - 2023 financial year and apologies for the lateness, but it's been a big year for changes.

On the 1st February 2023, Bubup Wilam had our 10 year anniversary at Main Street, Thomastown. Our achievements over the past 10 years are exceptional.

We have been punching above our weight and have developed into a specialist service for our Aboriginal children and families, ensuring that they have access to every educational opportunity available, through an Aboriginal community led and controlled service. We celebrated this achievement with a Gala Dinner at the San Remo Ballroom is Carlton.

Our favorite grandfathers of Bubup; Kutcha Edwards and Dave Arden entertained everyone with their beautiful music. Over 300 guests had attended that was made up of current and past families, Aboriginal community members and supporters who we have worked with. A great time was had by everyone.

We have been nominated for the National NAIDOC education Award to be announced on July 23. Regardless of the outcome, it is a great measurement of our work when one of our families nominated us for this Award. We are very thankful for this recognition.

During this year we had the departure of our accountant, it has taken a while to get back on track. We have outsourced and reviewed our accountancy/pay roll, and our HR processes. This is a long and drawn-out process.

In November 2022, Bubup Wilam put in a nomination to the State Government to be the sector representative for Early Childhood Development on the Closing the GAP Partnership forum. This is the first time Bubup Wilam has sat at the table and been seen as the representative for Early Years development.

This has already started to be an interesting journey of government maneuvering and decision making, for a small organisation to sit in this arena and participate at this level is going to be hard, but a necessary step in the future development of our sector.

Executive Officer's Report

Two PhDs being conducted at Bubup

The Bubup Wilam Approach: Privileging Community Control as a way forward for Aboriginal Early Years. - Lisa G Thorpe

Paving the way to de-colonising Aboriginal Early Years: The Bubup Wilam Approach - Angie Zerella

These PhDs are owned and controlled by Bubup Wilam, who the cultural authority on our projects. Both PhDs are at different stages; Angie's will be due for completion by August 2024 and mine is scheduled to be completed in November 2025. Both are about Bubup.

Lisa's PhD is about the philosophy of Aboriginal community control and how this played out in an early years setting. Angie's is about the working mechanisms on the ground, within the Early Years regulations, and how our families have responded. With the inclusive wrap around services that we offer to all our families, we were given an exceeding rating from ACECQA this year, which enables us to apply for a Centre of Excellence, we are awaiting the outcome of this recognition.

The research projects will document the journey through different lenses. It has been an exciting and intense journey, many roadblocks along the way, but still on track to complete. Angie and I will have all the honors of PhDs but the information and ownership belong with Bubup, we have used academic structures to develop Bubup to reach their full potential. It is still an uphill battle for us to be recognised and acknowledged for the groundbreaking work we have achieved on the ground.

YOORROOK Round Table

Bubup Wilam, Berrimba and Yappera all gave evidence at the Yoorrook round table hearing 2023 as part of the Commission's hearings on Child Protection and Criminal Justice systems. This was a great opportunity to speak about the struggles we all have as Early Years services when dealing with the Governmental institutions, we all had similar stories of frustration and unjust situations with our families who were caught up in the systems. Executive Officer's Report

Outsourcing of Accounts and HR

Due to our finance person resigning in April 2022. We have had to outsource our Finances and built up our HR processes through an outside agency. We are back on track and working to bring everything back into Bubup in the future.

Connected Beginnings

During this year we became a Connected Beginnings Backbone site for Whittlesea, this is a new program from the Commonwealth, and we are working through the processes of how this will work at Bubup.

Child Protection Training

In October 2022 we had 130 Child Protection workers from the North East Metropolitan attend or Racism Awareness Training. This ran over 5 weeks with 20 people at each session. It was a very successful training course, ranging from the leadership in the DFFH to the workers on the ground dealing with our people. We had their full attention for two days, only one person could not attend the full session due to illness. The Child Protection workers learnt a lot of new information hearing their knowledge gaps about the history of this country and how we as Aboriginal people are treated, they have never heard before, this confirmed why we have difficulties with the Child Protection workforce. This has created a stronger working relationship with the Child Protection department, it's just difficult to keep up with the changing workforce.

It's been a successful year. We are finally growing as an organisation and discovering new and exciting ways to stay relevant to our families.

Dja Dja Wurrung children (3YO) participated in a 8 week program - Learn to Swim at the Thomastown Aquatic Centre.


This enabled the children to learn about safety around water and learnt the basics of swimming such as; kicking their legs, floating, blowing bubbles and how to be safe in the water.


Some children were a little afraid, but overcome their fear by lesson 3.







Bubup Wilam Enrolment Numbers July 2022 to June 2023

Health and Wellbeing Report

BUBUP WILAM ABORIGINAL CHILD AND FAMILY CENTRE Health and Wellbeing Program

Bubup Wilam Aboriginal Child and Family Centre is committed to facilitating the learning and development of lifelong skills for the children that attend the service. We recognise that each child's holistic health, including psychological, spiritual and emotional wellbeing) underpins their educational outcomes. It is also recognised that integral to children's development is the health and psychological, spiritual and emotional wellbeing of their families and broader community.

The holistic nature of Bubup Wilam means that families are naturally supported and empowered by all the staff working at Bubup Wilam. This includes the Early Years Education Program, the Transition Program, the Health and Wellbeing Program and the Board and Management. Bubup Wilam teams work collaboratively and in unison to wrap around children and families to build strong families and communities who can advocate for themselves and their children. The focus is on the strengths of the child and the family.

Bubup Wilam also works in strong partnerships with VACCHO and the Victorian Aboriginal Health Service.

Integral to the work of Bubup Wilam is addressing the health and developmental needs of children and their families using a strength based approach and focusing on prevention and early intervention through the provision of Child Health Checks.

Bubup Wilam provides wrap around supports to children and families with the focus on empowering families to advocate for themselves and their children as they move through any significant challenges they face. Proactive, responsive formal and informal supports with a focus on prevention are provided to families in the areas of: housing, finance, employment, legal and justice matters, family violence, child protection, mental health.

Bubup Wilam continues its commitment to prevention and early intervention through the provision of Health Checks, Hearing Assessments (through HAPEE Ears) and Speech and Language Screenings.

Ongoing support is provided to children and families through the provision of ongoing speech pathology intervention and access to counselling and social and emotional wellbeing supports.

With the provision of these supports, children have access to assessments and treatments in a timely manner and are avoiding long waits for services through external providers such as community health.



1 Our Purpose

In partnership with families, Bubup Wilam for Early Learning aims to nurture strong proud and deadly kids in a culturally rich and supportive educational environment.

Our
Philosophy

Bubup Wilam meaning 'Children's Place' in the Woi Wurrung language seeks to underpin and strengthen our vision through the philosophy of instilling and strengthening children's strong sense of Aboriginal identity and personal self-esteem as their foundation for lifelong learning, health and wellbeing.

This equates to children, and with the support of their parents and extended family, taking a lead responsibility in owning and developing their play, space, interaction, learning and engagement with others in a confident and supported way. Guided by the teaching staff, we aim to ensure our children at a very early age to begin the journey in reaching their full human potential.

3 Our Journey

Bubup Wilam was established by the Aboriginal community and incorporated in 2010 with the aim of developing a new and innovative approach to Aboriginal Early Years, to change the life trajectory for Aboriginal children and their families. Underpinned by the concept of community control and self-determination, the Bubup Wilam Aboriginal Early Learning Centre opened its doors in January 2012. Bubup Wilam is managed, led and controlled by a board of nine Aboriginal people

Bubup Wilam is accredited against the Australian Children's Education and Care Quality Authority's (ACECQA) seven (7) National Quality Standards, and 2017 Bubup Wilam was rated by the Australian Government as 'exceeding National Quality Standards' for the exemplary model and best practice.

from the wider Aboriginal community and an Aboriginal CEO.

Bubup Wilam is respected as a Centre for Excellence and has won many awards, including Victorian Employer of the Year 2016 and was one of three finalists in the Australian Training Awards in the Medium Employer's Award for Training category.

In 2018, Bubup Wilam registered as an NDIS provider and ECIS service. Bubup Wilam was the first early childhood service in Victoria, the only Aboriginal early years' service nationally and one of three early childhood services in Australia to achieve this registration. In 2020, Bubup Wilam, successfully achieved accreditation against the National Disability Insurance Scheme (NDIS) practice standards.

Today, Bubup Wilam is a thriving Aboriginal community-controlled organization based in Thomastown. Our approach is based on the understanding that young Aboriginal children and their families need holistic, culturally safe, Aboriginal-led programs to support them to overcome entrenched social disadvantage, to have the opportunity to develop their potential throughout their lives, and to thrive within their communities and the wider world.






